Maintenance Report

<u>Concrete</u> – during a preventative property inspection, cracks were found in some of the decorative rock facing. The cracks have been repaired.

<u>Outdoor Lights</u> – most of the front door lights have been replaced, but we are still experiencing issues with one unit where the motion detector isn't functioning. That lamp will be replaced shortly.

<u>Fencing</u> – 4 posts were replaced on the north fence. Our fencing is in good condition overall and we continue to monitor and repair as necessary.

<u>Gutter Repairs</u> – ongoing as time and weather permits.

<u>Dryer Vent Cleaning</u> – technicians will be onsite on May 29. Please ensure that your outside vents are accessible. There may be a need to access some units from the inside. If you are at home, please allow the technicians entry as required.

<u>Windows</u> – according to the most recent home inspection, our windows are in good condition. Owners are reminded to inform Council if they have any issues with foggy windows or cracks in the window pane or frame.

Water Restrictions

Correspondance
